US-listed Stocks & ETFs, OTC Stocks and Options:

Fees charged by Public Investing are listed below. Regulatory agencies charge us fees for certain trades, which we pass onto you; see the “Regulatory Trading Fees” section below. If you are investing in stocks and ETFs as part of an Investing Plan, the fees described in the “[Investment Plans](#)” section below apply instead.

Margin Interest Rate:

Prior to November 1, 2024, the margin interest rate is 0% on margin accounts. Beginning on November 1, 2024, the margin interest rates on margin accounts shall be as follows:

Margin / Debit Balance	Margin Interest Rate*
Up to \$10,000	FFTR + 5%
\$10,001 – \$50,000	FFTR + 4%
\$50,001 – \$250,000	FFTR + 2%
\$250,000 and above	FFTR + 1%

* For margin accounts, Public Investing charges a margin interest rate that varies depending on your margin/debit balance and the upper limit of the Federal Funds Target Range. This upper limit, which is defined as “FFTR” in the table above, is set by the Federal Reserve and is subject to change without notice. The formulas used to calculate the margin interest rates above are subject to change at Public Investing’s discretion. As of September 19, 2024, the FFTR is 5% but may change at any time without notice via this Fee Schedule or otherwise.

Trading in cryptocurrencies offered by Bakkt Crypto, which charges a transaction fee of 1.25% per order.

Cash in your High-Yield Cash Account is swept to [Partner Banks](#), where it earns interest. Partner Banks pay Apex Clearing and Public Investing administrative fees for operating this program, which impacts the interest rate that they pay to our members on swept cash.

Alternative Assets:

Dalmore Group, LLC (“Dalmore”) acts as broker-dealer to facilitate the trading of alternative asset securities and charges the commission below to both the buyer and seller on each completed trade.

The issuer of alternative asset securities may pay additional fees (described in the applicable offering circulars) that can affect investor returns. This includes 10% of profit on liquidation and, where applicable, a percentage of free cash flow. These fees are not charged directly to investors.

Jiko Treasury Account:

On Public, you can open a “Treasury Account” with Jiko Securities, Inc. (“Jiko”), a separate broker-dealer registered with FINRA and SIPC. A Treasury Account is a Jiko brokerage account that allows you to easily make recurring investments in 6-month US Treasury Bills for as little as \$100. Jiko charges its customers a monthly management fee, which it deducts from your Jiko Treasury Account. If there is insufficient cash in your Jiko account to cover this fee, Jiko may sell treasuries held in your Jiko treasury account to cover any shortfall.
